

**2014-15 UPPER DECK DIAMOND DRAFT SWEEPSTAKES
OFFICIAL RULES**

NO PURCHASE NECESSARY TO ENTER OR WIN. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.

NAME OF CONTEST: 2014-15 Upper Deck Diamond Draft Sweepstakes

SPONSOR: This Contest is sponsored by The Upper Deck Company, 2251 Rutherford Rd., Carlsbad, CA 92008, which is solely responsible for its content ("Sponsor").

ELIGIBILITY: The 2014-15 Upper Deck Diamond Draft Sweepstakes (the "Game") is open only to legal residents of the fifty (50) United States and Canada and you must be thirteen (13) years of age or older as of December 3, 2014. Void in Puerto Rico, Quebec Province and where prohibited or restricted by law. Employees of The Upper Deck Company and its related companies, dealers, licensors, distributors, agents, advertising agencies, promotional suppliers, service agencies, independent contractors, as well as the immediate family and household members of each such individual are not eligible. By participating, each player agrees to be unconditionally bound by these Official Rules and the decisions of Sponsor, which are final and binding in all respects.

AGREEMENT TO OFFICIAL RULES: By participating, entrants agree to abide by and be bound by these Official Rules and the decisions of the Sponsor, which are final and binding in all matters relating to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

PRIZES: Twenty-Five (25) 1-of-1 shadowbox-style cards featuring a 2014-15 Quad Diamond Rookie, and showcasing **lab created diamonds** inside ("Prize"). Each Prize will feature a different subject and is unique.

Each Prize has an Approximate Retail Value ("ARV") of one hundred fifty dollars (\$150.00). Approximate Retail Values (ARV's) on prizes are just that, approximations and are not guarantees of price or value. Prices of collectibles are affected by changing supply & demand, by local market conditions, by the unpredictability of sports and other factors. It is impossible to establish an exact value on prizes or predict price movements based on these conditions. Sponsor reserves the right to substitute the Prize or prize component with another of comparable or greater value. All prize awards are subject to verification of eligibility, verification and compliance with these Official Rules. The actual odds of winning a prize depends on the total number of trading packages sold and the total number of mail-in requests received during the Promotion Period. Limit one (1) Prize per person, per household and per email address.

TWO WAYS TO ENTER: The Sweepstakes begins at 12:00am Pacific Standard Time (“PST”) on December 3, 2014 and ends at 12:00 p.m. PST on April 9, 2015 (“Sweepstakes Period”). The Sponsor’s database computer is the official time-keeping device for the Sweepstakes. Two (2) entry methods are as follows:

1. Twenty-four (24) Redemption Cards (“Redemption Cards”) will be randomly inserted into 2014-15 Black Diamond Hockey Hobby Packs. Each of these Redemption Cards will entitle the holder to an entry into the Prize Draw (as defined below). If you find a Redemption Card, go to our website at www.upperdeck.com, clicking on “My Upper Deck”, click on “My Redemptions” and following the easy step-by-step instructions. Alternatively, you may also call (800) 873-7332, and make your reservation via telephone through a company representative. Please note that mail-in redemptions are no longer accepted (“Redemption Card Entry”).

2. **NO PURCHASE NECESSARY:** You may enter, without purchase, to win a Redemption Card by mailing any entry on a 3” x 5” note card to the following address: The Upper Deck Company, Attn: 2014-15 Black Diamond Hockey – Quad Diamond Rookie Gems Relics Sweepstakes, 2251 Rutherford Rd., Carlsbad, CA 92008 (“No Purchase Entry”). All No Purchase Entries must contain the following information from the Entrant: name, address, phone number, birth date and email address.

SELECTION OF WINNERS OF THE NO PURCHASE NECESSARY MAIL IN ENTRIES:

Winner will be selected in a random drawing, with equal odds of winning as if the entrants had made a purchase, from all eligible entries received by Sponsor, whose decisions regarding all aspects of the Sweepstakes shall be final and binding (“Prize Draw”). If a winner declines to accept a prize, or in the event that a prize or prize notification is returned as undelivered, the winner will be disqualified and the Sponsor may elect, at its own discretion, to select an alternate winner. By participating, entrants release Sponsor(s), their parents, subsidiaries, affiliated businesses, their advertising and promotion agencies and the officers, directors, employees and agents of each from any and all liability, damages or causes of action (however named or described) for injuries, damages or losses to persons and property which may be sustained in connection with receipt, enjoyment, ownership or use of the prize, and (except residents of Tennessee) winner grants permission to Sponsor to use winner's name, age, city, state, photograph or likeness for advertising and promotional purposes without additional compensation or approval (where lawful).

Winners will be entered into a draft to pick which of the twenty-five (25) cards the winner wishes to choose. The draft order will be decided randomly and will be held on April 14, 2014. A “ping pong style” draft will be utilized to pick the draft order for the selection of the Prize. The Prize selection will take place on April 14, 2014. If you are not able to participate in the live draft, a card will be selected for you based on the most recent Beckett value of the corresponding base card from the 2014-2015 Black Diamond base set. Any cards found after April 9, 2015 at 12:00 pm PST will not be eligible for this Sweepstakes. Draft entry is non-transferable. Winner shall be responsible for timely communicating any change of address or contact information to Upper Deck.

Proof of entering information at a website or mailing of an entry is not considered proof of delivery to or receipt by Sponsor of an entry. Entries made by any other individual or any entity, and/or originating at any other web site or e-mail address, including, but not limited to, commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for this Sweepstakes. The use of automated entry devices is prohibited and no mechanically reproduced entries are allowed; all such entries are void. The Sponsor is not responsible for: late, incomplete, incorrect, delayed, garbled,

undelivered, or misdirected entries. Sponsor reserves the right to disqualify any person or e-mail address that submits more than maximum allowed entries. All entries become the exclusive property of Sponsor and will not be acknowledged or returned.

GENERAL CONDITIONS: If for any reason the operation or administration of this Sweepstakes is impaired or incapable of running as planned for any reason, including but not limited to (a) infection by computer virus, bugs, (b) tampering, unauthorized intervention, (c) fraud, (d) technical failures, or (e) any other causes beyond the control of the Sponsor which corrupt or affect the administration, security, fairness, integrity or proper conduct of this Sweepstakes, the Sponsor reserves the right at its sole discretion, to disqualify any individual who tampers with the entry process, and to cancel, terminate, modify or suspend the Sweepstakes in whole or in part, at any time, without notice and award the Prizes using all non-suspect eligible entries received as of, or after (if applicable) this cancellation, termination, modification or suspension date, or in any manner that is fair and equitable and best conforms to the spirit of these Official Rules. Sponsor reserves the right, at its sole discretion, to disqualify any individual deemed to be (a) tampering or attempting to tamper with the entry process or the operation of the Sweepstakes or Sponsor's website; or (b) acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.

CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THE SWEEPSTAKES IS A VIOLATION OF CRIMINAL AND CIVIL LAWS AND SHOULD SUCH AN ATTEMPT BE MADE, THE SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW. Failure by the Sponsor to enforce any provision of these Official Rules shall not constitute a waiver of that provision. In the event of a dispute as to the identity of a winner based on an e-mail address, the winning entry will be declared by the authorized account holder of the e-mail address submitted at time of entry. "Authorized account holder" is defined as the natural person who is assigned to an e-mail address by an Internet access provider, on-line service provider or other organization (e.g., business, educational, institution, etc.) that is responsible for assigning e-mail addresses for the domain associated with the submitted e-mail address.

Released Parties assume no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of, entries. Released Parties are not responsible for any problems or technical malfunction of any telephone network or telephone lines, computer on-line systems, servers, or providers, computer equipment, software, failure of any e-mail or entry to be received by Sponsor on account of technical problems, human error or traffic congestion on the Internet or at any website, or any combination thereof, including any injury or damage to participant's or any other person's computer relating to or resulting from participation in this Sweepstakes or downloading any materials in this Sweepstakes. Entrant further agrees that in any cause of action, the Released Parties' liability will be limited to the cost of entering and participating in the Sweepstakes, and in no event shall the Released Parties be liable for attorney's fees. Entrant waives the right to claim any damages

whatsoever, including, but not limited to, punitive, consequential, direct, or indirect damages. Participants agree that Released Parties have not made nor are in any manner responsible or liable for any warranty, representation, or guarantee, statutory, express or implied (including but not limited to the implied warranties of merchantability, title and fitness for a particular purpose), in fact or in law, relative to the Sweepstakes. The potential winner will be notified by email and must sign and return to Sponsor, within ten (10) days of the date of notice or attempted notice is sent, an Affidavit of Eligibility, Liability & Publicity Release in order to claim his/her prize. IN NO EVENT WILL RELEASED PARTIES BE RESPONSIBLE OR LIABLE FOR ANY DAMAGES OR LOSSES OF ANY KIND (INCLUDING WITHOUT LIMITATION, LOSS OF PROFITS, CLAIMS OF THIRD PARTIES, DIRECT, INDIRECT, INCIDENTAL, CONSEQUENTIAL, OR PUNITIVE DAMAGES) ARISING OUT OF PARTICIPATION IN THIS SWEEPSTAKES OR THE ACCEPTANCE, POSSESSION, USE, OR MISUSE OF, OR ANY HARM RESULTING FROM THE ACCEPTANCE, POSSESSION, USE OR MISUSE OF THE PRIZES.
