

**2015 GET DRAFTED BY UPPER DECK SWEEPSTAKES
OFFICIAL RULES**

SPONSOR: This Sweepstakes is sponsored and administrated by The Upper Deck Company, 2251 Rutherford Road, Carlsbad, California 92008, which is solely responsible for its content ("Upper Deck" or "Sponsor"). Sponsor and NHL Enterprises, L.P., NHL Enterprises Canada, L.P., NHL Enterprises B.V., NHL Interactive CyberEnterprises, LLC, the National Hockey League (the "NHL") and its member clubs (collectively, these NHL entities are the "NHL Entities"), and their respective parents, divisions, affiliates, subsidiaries, advertising agencies, promotional partners, and prize providers associated with this Sweepstakes collectively are referred to herein as the "Released Parties" and each a "Released Party." Upper Deck will draw winners from among the Authorized Internet Retailers’ winners on Friday, June 5, 2015 at 1:00 p.m. PST.
